### Recent Publications

#### **The Formation, Governance, Financing Mechanisms and Mandate of Public Interest, Community-based Environmental Law Centres - [access this report](#)**

CIELAP's report analyzes survey results from **22 environmental law centres around the world** to gather background information about how they were established, how they are governed and financed, and how they organize themselves. The report also highlights the important role environmental law centres are playing to engage civil society.

Interesting findings include:

- While most respondents (79%) feel that their country has strong laws, only 21% feel that these laws are well implemented and enforced.
- Organizations are involved in an array of activities to meet their objectives. The main tools are research (79%), advocacy (74%), offering advice to governments (68%) and influencing policy (63%).
- Respondents feel that the most important measures for compliance with environmental laws are: strong media participation; education; and access to information.

## CIELAP Knowledge Cluster Meetings

### Youth and Community Engagement - April 27 2006

CIELAP works to engage youth and members of our community in environmental law and policy. Participants of the April knowledge cluster discussed how to engage young people and members of our community in the environmental debate.

### Waste Incineration - May 25 2006

CIELAP is currently conducting research into waste incineration. **Maureen Carter-Whitney, CIELAP Research Director**, led our knowledge cluster session on this topic to seek input on the project from participants. **A research paper examining this issue is underway; check our website in the fall to access it.**

## CIELAP Out in the Community

Anne Mitchell, CIELAP's Executive Director attended a meeting of the **Public Advisory Panel of the Canadian Plastics Industry Association** in April. The focus of the discussion was energy from waste. Anne reminded the panel of the sustainability issues that need to be addressed.

In May she and Susan Holtz, Senior Policy Analyst, participated in the **Pharma Workshop** where Susan presented CIELAP's paper entitled '**There is no Away: Pharmaceuticals personal care products and endocrine disrupting substances in water**'. In June, Anne participated in the **National Pollutant Release Inventory (NPRI) Working Group** meetings as an ENGO delegate through the Canadian Environmental Network.

In addition, she participated in a stakeholder discussion on how to raise public awareness about the NPRI in Canada. CIELAP has been active in this area. We published a **Citizens' Guide** to the NPRI in 2000, maps indicating **pollution hotspots** across the country and some suggestions for teachers.

Maureen Carter-Whitney spoke on CIELAP's research on pharmaceuticals in water at **Freshwater for the Future**, a conference on water policy hosted by the Government of Canada's Policy Research Initiative held in Gatineau, Quebec on May 8-10, 2006.

On June 5, 2006 Maureen participated in the **Ministry of Municipal Affairs and Housing's Brownfield Stakeholder Group** which offers advice to government on the implementation of its brownfield laws and regulations.

**Coming up!** June 27-28, 2006 Maureen will make an oral statement before the **Thirteenth Regular Session of the Council of the North American Commission for Environmental Cooperation** in Washington, D.C. She will urge the CEC to broaden its work to address emerging contaminants such as pharmaceuticals and products of biotechnology and nanotechnology applications.

Comment on the latest issues of environmental concern that relate to CIELAP's work and research.

The Ontario government wants your feedback on a proposal entitled "***Designation of Municipal Hazardous or Special Waste under the Waste Diversion Act, 2002***". This proposal is posted on the Environmental Registry of Ontario's **Environmental Bill of Rights (EBR)** for comment until **July 09, 2006**.

The aim of the posting is to receive public feedback on the intention to require "Waste Diversion Ontario to develop a waste diversion program for municipal hazardous or special waste... This is the first step in the process that will lead to a waste diversion program for these materials."
