## **RECENT RELEASES**

### **CIELAP Releases its 1998 NPRI Poster**

On March 20, 2001, CIELAP released a follow-up to its 1996 Canadian Pollutant Releases and Transfers (NPRI) poster. The new poster uses data from the 1998 National Pollutant Release Inventory (NPRI) to depict facilities across Canada with the greatest releases and transfers of carcinogenic and non-carcinogenic pollutants.

Over 3000 posters have been distributed to schools, libraries, universities, government officials, companies, and to individuals across Canada. ### **CIELAP and its Partners Launch [PollutionWatch.org](http://PollutionWatch.org)**

On April 10, 2001, the Canadian Institute for Environmental Law and Policy (CIELAP), the Canadian Environmental Law Association (CELA) and the Canadian Environmental Defence Fund (CEDF) launched a new website [PollutionWatch.org](http://PollutionWatch.org).

Two years in the making, [PollutionWatch](http://PollutionWatch.org) provides Canadians with environmental information at the click of a button. Simply type in your postal code and get a list of the top polluting facilities in your community and the types of pollutants being released. [PollutionWatch](http://PollutionWatch.org)

integrates data from the 1999 National Pollutant Release Inventory with over 300 databases to provide a detailed environmental report for your province, community and facilities in your area.

PollutionWatch also provides users with easily accessible and easy-to-understand information on chemicals, the potential health risks, and on federal and provincial regulations in Canada. Lastly, you can TAKE ACTION, by faxing a free letter to facilities in your neighbourhood directly from the website.

The launch of PollutionWatch was enormously successful. In addition to the media coverage, over 1.8 million hits were registered on the website for the first day.

Congratulations to the staff of the three organizations who worked so hard on the PollutionWatch project over the past year: Fe de Leon (CELA), Mary McGrath (CEDF - PollutionWatch Outreach Coordinator), and James Yacoumidis (PollutionWatch Website Coordinator).

## **NEW AND ONGOING PROJECTS**

### **CIELAP Sets the Federal Agenda**

Throughout the fall and winter, CIELAP was working on a report entitled "Canada's Federal Agenda for a Sustainable Future" for the federal government. By spring of 2001, CIELAP's document will show the way government should go to achieve sustainability. The report will review the trends in key areas such as consumption and waste, toxics and pollution, habitat and biodiversity conservation and make recommendations on policy options.

### **CIELAP Joins Exciting New Research Alliance**

In the fall of 2000, CIELAP joined nine other environmental groups, the City of Toronto, the University of Toronto and York University in a joint community/university research project. With the working title "Sustainable Toronto", the project matches up the energy and expertise of university students and faculty with on the ground research needs of environmental groups. Funded by the Social Sciences and Humanities Research Council of Canada, "Sustainable Toronto" is unprecedented and very promising. CIELAP's project focuses on gathering existing data about water resources in the province of Ontario. A web site based resource and a report will be our first product from our Sustainable Toronto partnership, with more to come in the future.

### **CIELAP Highlights its Right-To-Know Initiatives at NAFEC's Workshop in Mexico City**

In March 2001, Anne Mitchell, CIELAP's executive director, participated in a workshop organized by the Commission on Environmental Cooperation on the use of Pollutant Release Inventory data. Anne gave a presentation on the educational tools CIELAP has developed and some of the activities CIELAP s engaged in to enable Canadians to become more aware of the data and how to use it. These tools include the 1998 NPRI poster, the [Citizen's Guide to the NPRI](#) and the recently launched [Pollutionwatch.org](http://Pollutionwatch.org) website.

### **CIELAP and Biotechnology**

During the past two weeks in April, the Canadian Biotechnology Advisory Committee (CBAC)

of which CIELAP's Executive Director is a member, held stakeholder consultations in five Canadian cities on the regulation of genetically modified agricultural products. The results of these consultations will help inform CBAC as it prepares advice for the seven Federal Ministers to which it reports. Unfortunately, a major sector of the Canadian public, many non-government organizations and civil society organizations, decided to abstain from participating. These groups felt that the majority of the folks who make up CBAC are too biased toward the biotechnology industry and that in any case, the Canadian Government sees biotechnology as the growth and job creator of the 21st century and will not do anything to slow down the industry's development. Another concern is that this is a societal issue and it should be parliament that is conducting consultations and not an advisory committee whose advice the government can ignore.

When CBAC next meets in June to evaluate the stakeholder consultation process and determine what advice it is going to give to government, the concerns of those who did not participate will have to be given as much consideration as the concerns of those who did.

## **CIELAP and the Global Environment**

CIELAP's Executive Director spoke to a gathering in April 2001, organized by the Unitarian Church, on the Global Environment. This was part of a month long seminar series on globalization, as the group decided what it could do to address some of the social justice issues which are not being addressed currently through the FTAA discussions.

## **CIELAP Attends NRTEE's First Stakeholder Workshop on Environment and Sustainable Development Indicators**

In March 2000, Karen Clark, CIELAP's Legal Analyst, and Jennifer McKay, traveled to Ottawa to attend the National Round Table on the Environment and Economy's (NRTEE's) First Stakeholder Workshop on Environment and Sustainable Development Indicators Initiative.

At the workshop, the NRTEE presented their proposed framework for a set of national sustainable development indicators. The workshop provided CIELAP with the opportunity to comment on the proposed framework. The workshop also provided important information to be integrated into CIELAP's Canada's Federal Agenda for a Sustainable Future report.

## **CIELAP to Present at the Strategy Institute's Innovative and Cost-Effective Garbage Management Strategies**

In April 2001, James Yacoumidis, CIELAP's Project Officer will be presenting an update on CIELAP's Open for Toxics report. James will highlight hazardous generation and receipt trends from 1994 to 1998 and an update for 1999.

## **CIELAP Participates in Environment Canada's Consultations on PCB Import and Export Regulations**

In early 2001, James Yacoumidis, CIELAP's Project Officer attended an Environment Canada consultation on proposed regulations concerning the import and export of PCBs in Canada. The workshop provided a forum for CIELAP to express its views on the environmental implications of the proposed regulation.

## **CIELAP to Participate at the People's Summit of the FTAA**

CIELAP's Executive Director, Anne Mitchell, student intern, Amanda Montgomery and volunteer, Shelagh Whitley are going to Quebec City, April 17 to participate in the Peoples' Summit of the FTAA. There they will be joined by Roxana Salazar, Executive Director, and Max Valverde, of Fundacion Ambio, partner organization in Costa Rica. Together, CIELAP and Fundacion Ambio will offer a workshop and discussion on why regulation is necessary for genetically engineered agriculture products to ensure that the environment, our health and the planet's biodiversity is protected. Fundacion Ambio and CIELAP will present their work together, based on the paper entitled Biosafety, Consumer Protection and International Trade (see our website at [www.cielap.org](http://www.cielap.org)).

CIELAP and Fundacion Ambio will also participate in the FTAA Symposium, organized by the International Institute for Sustainable Development (IISD), the International Union for the Conservation of Nature (IUCN) and the National Roundtable on the Environment and the Economy (NRTEE).

As well, we will take part in many of the other activities taking place in Quebec. We trust that the protests will be peaceful and that the leaders of the Americas will come to understand that many of us are not against trade but that labour and human rights and the environment have to be protected and that the benefits of trade have to be redistributed to address the abject poverty that many people in all countries of the Americas are experiencing.

We will give you a report on our workshop in our next e-letter.

### **CIELAP Plans for the Future**

At the end of May, CIELAP board and staff will meet together for a day to plan our work for the July 2001 to June 2002. There are many issues needing work and our task will be to figure out what is the value added of our work and what is unique that CIELAP can contribute. The issues are complex and there are no easy, quick fixes. We are in this for the long-term. Perhaps CIELAP can contribute this perspective and help visualize the Canada - and the world - that we would like our children and grandchildren to inherit. We can then work backwards and figure out what we have to do to get there. What does it mean to live sustainably in the 21st century? What can Canada say to the rest of the world when we report on progress in the fall of 2002, ten years after the Earth Summit when the world committed to striving towards sustainable development?

And it is not just CIELAP that is considering these questions. Many other organizations, sectors, corporations, faith groups and governments are trying to identify the best way forward so that we can better live in harmony with each other and with nature in the 21st century.
