[Multi-Stakeholder Workshop to Develop an Appropriate Policy Framework for Nanotechnology](#)

On March 16, 2007 CIELAP assembled members from a cross-section of perspectives, including government, industry, non-profits, and academics, to discuss how to move towards an appropriate policy framework for Nanotechnology, a technology that cuts across much of CIELAP's efforts in understanding the effects of new and developing technology. Out of the discussions and based on additional research CIELAP Senior Policy Analyst Susan Holtz prepared a [Discussion Paper](#) on a Policy Framework for Nanotechnology.

[Ontario's Waste Management Challenge – Is Incineration an Option](#)

On March 26, 2007 CIELAP proudly released **Ontario's Waste Management Challenge – Is Incineration an Option** written by CIELAP's Research Director Maureen Carter-Whitney. This paper provides background and context for the incineration debate in Ontario by setting out the advantages and disadvantages of incineration technologies; reviewing current and proposed regulations relating to municipal solid and hazardous waste; and discussing the place of incineration within the context of a waste management hierarchy. The paper concludes with a policy perspective on incineration and 11 recommendations for Ontario.

## Environment in the Media

**On March 28, 2007** the Canadian Press published a story and comments made by Premier Dalton McGuinty, who joined the incineration debate arguing that burning garbage to create energy could be a solution to overloaded landfill sites and Ontario wants to be ahead of the pack in developing incineration technology.

New Democrat critic Peter Tabuns stated, "This premier is caught up with convenience in dealing with a problem and is not interested in sustainability or dealing with climate change."

The article reported CIELAP's position that "waste management needs to be led not by technology, but by a strong comprehensive waste-management policy framework . . . and we're hoping it would reflect a strong emphasis on waste reduction and diversion."

## Law and Policy in Ontario – Opportunities for you to Comment

**The Ontario Government wants your comments on a number of proposals:**

**[A Review of Ontario's Species at Risk legislation:](#)** The Ontario government is undertaking a review and update of the province's species at risk legislation to provide for broader protection and recovery of species at risk and their habitats. Written comments are accepted until **April 19, 2007**.

**[Bill 198 - Safeguarding and Sustaining Ontario's Water Act, 2007:](#)** Implementing the Great Lakes - St. Lawrence River Basin Sustainable Water Resources Agreement. Written comments are accepted until **May 3, 2007**.

**[Proposal to amend Ontario Regulation 419/05: Air Pollution – Local Air Quality under the Environmental Protection Act:](#)** The Ontario Ministry of the Environment (MOE) is proposing to amend Ontario Regulation 419/05: Air Pollution - Local Air Quality (O. Reg. 419/05) to introduce new or updated standards for 15 substances. Comments may be made until **May 7, 2007**.

**[Regulations under the Clean Water Act:](#)** Draft regulations that provide the details needed to get local source protection planning started are available on the Environmental Registry. Written comments will be accepted until **May 12, 2007**.

**Canada-Ontario Agreement Respecting the Great Lakes Basin Ecosystem (COA)**: Canada and Ontario have negotiated a draft 2007 COA that has been posted for public comment until **May 16, 2007**.

**Revised Statement of Environmental Values, Ministry of Government Services and Ministry of Agriculture, Food and Rural Affairs**: The Ontario Ministry of Agriculture, Food and Rural Affairs has made proposed changes to its Statement of Environmental Values, and these changes are available for review and comment on the Environmental Registry. Comments may be made until **May 17, 2007**

**Update of Brownfield Soil and Ground Water Standards**: The Ontario Ministry of the Environment is considering an update of the document entitled "Soil and Ground Water and Sediment Standards for Use Under Part XV.1 of the Environmental Protection Act" (Site Condition Standards) published by the Ministry and dated March 9, 2004, which is part of Ontario Regulation 153/04. Comments may be made until **May 22, 2007**.

**Water Conservation Charges Proposal**: The Ministry of the Environment is proposing a new charge designed to recover some of the costs of provincial water management programs. The purpose of this posting is to consult on the details of the proposed charge. Written comments may be made until **June 4, 2007**.
