The Board of Directors of CIELAP at its January 2002 meeting approved CIELAP's new three-year strategic plan. The plan identifies four program areas for the next three years: Sustainable Policy Solutions; Governance for Sustainability; Public and Community Engagement; and Youth Leadership. With this new plan, CIELAP seeks to move away from a project specific focus toward one centered around program planning and development. The plan also identifies the need for CIELAP to expand its capacity. We hope to complement our tradition of comprehensive research with other important functions such as community outreach, the development of sustainability models, and the mentoring of future environmentalists.

You will read about our many successes during the year in this annual report. Our sincere thanks go to staff, volunteers, interns, board members, funders and all of you for your help to CIELAP in the past year. We look forward to another year of successes as we move forward together to support the process of developing more stable and sustainable communities.

CIELAP'S MISSION AND VISION

Founded in 1970, CIELAP is an independent, not-for-profit research and education organization whose mission is to provide leadership in the research and development of environmental law and policy that promotes the public interest and sustainability.

Our vision is a world in which basic human rights include a safe and healthy environment, achieved through respect for, and preservation of, nature's integrity and diversity.

Goals:

- i) To promote an effective and accountable environmental legal and policy framework
- ii) To enhance and promote environmental action on the public and political agenda

During the past year we have published a number of discussion papers and reports, organized a number of workshops and completed a number of projects which help us meet our goals.



RESEARCH PROJECTS AND PUBLICATIONS

 $\frac{\text{A YEAR}}{\text{IN REVIEW}}$

In December 2001, CIELAP, along with Faculty of Environmental Studies at York University, as part of Sustainable Toronto, released *Liquid Assets – Monitoring Water Quality in Ontario*.

In January 2002, CIELAP published its 6th Annual Report on Ontario's Environment which examines government policies and actions in five major areas: water quality and quantity, air quality and monitoring, hazardous wastes and brownfields, and compliance and enforcement of environmental rules and regulations.

In February, CIELAP, the David Suzuki Foundation and the Toronto Renewable Energy Co-Operative (TREC) released a report entitled *Green Power Opportunities for Ontario*. The report revealed that Ontario has enough capacity to close coal-fired electricity plants and increasingly rely on a combination of energy efficiency and renewable energy options.

At the end of May 2002, Honourable Justice Dennis O'Connor released the final Walkerton Report detailing ways to ensure that the drinking water in Ontario is not contaminated. CIELAP responded to "Walkerton II" by compiling the main recommendations in order to evaluate the government's response to the report and to protect Ontario's drinking water. The report recommends that the government develop a comprehensive drinking water policy and enact a Safe Water Drinking Act to implement that policy.

In May, CIELAP released an updated edition of one of our most successful publications, the *Citizens Guide to Biotechnology*. The publication informs citizens about the development of biotechnology in Canada. It includes information on the current trends in the application of biotechnology, the concerns surrounding its side effects and an overview of the type of policy framework Canada needs in order to regulate biotechnology.

In August 2002, CIELAP released a discussion paper entitled *Sustainability Impact Assessment of the Earth Summit* + 10. We were able to release this paper on the eve of the World Summit on Sustainable Development, held in Johannesburg.

In October 2002, we released a report entitled *Ensuring Green Power Supplies in Ontario: Responding to Perverse Subsidies and Other Market Inequities*. This report formed the basis for CIELAP to file a complaint under the Competitions Act.

In collaboration with University of Toronto cartographers, we developed the 3rd NPRI (National Pollutant Release Inventory) map, which details the types and impacts of pollution in Canada. This year CIELAP created two maps: one for high school students, and one for a younger audience.

The PollutionWatch website, a joint project with the Canadian Environmental Law Association and the Environmental Defence Canada is being 'repatriated' to Canada so that we can managed its financing and keep it going. Look for the launch of the new PollutionWatch website early in 2003.

During the year we also worked on a project on mining with our partner in Peru. The research paper, a case study on public participation in the environmental assessment of mining initiatives, will be published as part of a collection of case studies by the International Development Research Centre (IDRC).

A YEAR In Review

During the year we revised and updated *Open for Toxics* about the management of hazardous waste in Ontario. This publication will be released before the end of 2002.

CONFERENCE AND WORKSHOPS

On October 2001, CIELAP, collaborating with the Sierra Club and the Toronto Environmental Alliance, sponsored the 2nd Annual Green Power Trade Show. The show provided a forum for Green Power producers, facilitated a number of workshops on Green Power markets and informed consumers on how to demand green power. The 3rd Show was held on October 28 and 29, 2002 at the Westin Harbour Castle Hotel in downtown Toronto.

In April 2002, CIELAP held a conference entitled "Partnering for Sustainability", in conjunction with the Strategy Institute. This successful conference, attended by over 200 delegates from government, academia, non-government organizations and the private sector, was based on a report published by CIELAP in November 2001 entitled "Sustainable Development in Canada: A New Federal Plan". The document outlined a four-step sustainable development strategy for Canada. The steps include: the identification of sustainable development objectives, the establishment of specific goals and targets, and the measurement of and testing for sustainability.

On April 26th, 2002, CIELAP and York University's Faculty of Environmental Studies (as part of the Sustainable Toronto project) co-hosted a successful workshop for Ontario's Conservation Authorities. The workshop allowed watershed managers from across Ontario to share their experiences, challenges and issues regarding water quality management in Ontario.

In June 2002, CIELAP attended a workshop in Mexico City where NGOs from the US, Canada and Mexico discussed how they can use Pollutant Release Inventory data to alert communities to environmental problems. CIELAP was able to showcase some of its work using the National Pollutant Release Inventory (NPRI) data.

Summer Sail: On the sunny, but cool and breezy evening of June 27th, CIELAP held its fourth annual Summer Sail aboard The Challenge on Lake Ontario. In recent years, this has been one of our main events that raise money to support our research projects. This year, the event included a special ceremony that highlighted the achievements of our much valued volunteers.

Our Open House: which was held on July 18th, gave the public a chance to see our new office, meet our new staff members and review our recently released publications. We unveiled our new information package which contains a CIELAP chronology, a brief history and a glimpse of future projects. We entertained a full house and everyone enjoyed seeing both old and new faces. We would like to thank our volunteers for helping us to make this event a success.



Planning for Sustainable Development:

In October of 2001, CIELAP staff traveled to Ottawa to meet with senior bureaucrats in the departments of Environment, Natural Resources, Health, and Finance, to discuss sustainable development strategies. They circulated there the paper, Sustainable Development in Canada: A New Federal Plan which critically evaluates the rhetoric surrounding sustainability. It discusses the struggle to define the term, the use of indicators, and the role of innovation in moving towards a more sustainable society and specifically examines Canada's approach towards sustainable development.

Our Partnership with Fundacion Ambio in Costa Rica:

In February of 2002, Anne Mitchell, CIELAP's Executive Director, traveled to Costa Rica to complete a three-year program on sustainable agriculture and the agricultural products of biotechnology. With the help of CIDA, CIELAP and Fundacion Ambio worked together to successfully develop a policy framework to regulate the agricultural products of biotechnology in Costa Rica.

CIELAP is looking forward to repeating the success in Costa Rica by forming a partnership with the Advocates Coalition for Development and Environment (ACODE), a Ugandan NGO. The goal is to apply the knowledge gained from the Costa Rican experience and to assist ACODE with the development of biotechnology legislation.

Biotechnology and Patenting:

In March 2002, Anne Mitchell was reappointed to the Canadian Biotechnology Advisory Committee (CBAC). The Committee, established by the Federal Government, advises on issues related to biotechnology. Anne registered a minority view on both biotechnology and patenting.

In May, the Canadian Environmental Law Association representing CIELAP and other environmental non-government organizations and lawyers representing the Canadian Council of Churches argued before the Supreme Court that higher life forms (that is, plants and animals) should not be patented. The lawyers argued that it was never envisioned in 1869 when the Patent Act was passed, that the Act would be interpreted to include plants and animals. A decision on this case will be made this fall.

Participation in the World Summit on Sustainable Development:

In September Anne headed south to Johannesburg, South Africa for the first time in roughly 10 years (she previously traveled there as an anti-apartheid advocate). She served as a delegate to the World Summit on Sustainable Development (WSSD), representing several organizations including CIELAP and the Canadian Environmental Network (CEN). She posted comments on the summit proceedings on our website and you may have received her emails from South Africa. CIELAP hopes to host a seminar later this year to discuss and evaluate the summit proceedings and help identify program priorities for CIELAP in the coming year.

We thank them all for their hard work during the year.

CIELAP'S FINANCES

The firm, Pricewaterhouse Coopers (PWC) has audited the statement of financial position of the Canadian Institute for Environmental Law and Policy (CIELAP) as at June 30 2002 and the statement of financial activities and surplus and cash flows for the year then ended. In PWC's opinion, "these financial statements present fairly, in all material respects, the financial position of the Institute as at June 30 2002 and the results of its operations and its cash flows for the year then ended in accordance with Canadian generally accepted accounting principles".
