New poll shows 84% want Ontario to spend more on environmental protection

A large majority (84%) of Ontarians believe that "the government of Ontario should spend more money on environmental protection and restore funding to the Ministry of the Environment" according to a poll released today by the Canadian Institute for Environmental Law and Policy (CIELAP).

"The people of Ontario want Queen's Park to provide more - not less - environmental protection," said Anne Mitchell, Executive Director of the Canadian Institute for Environmental Law and Policy.

CIELAP has issued annual reports on the impact of the Common Sense Revolution on environmental protection. The detailed studies have charted a severe deterioration of environmental enforcement staff, budget and regulations since 1995. The reports are called "Ontario's Environment and the Common Sense Revolution." The most recent edition (the fourth year report) is available on the CIELAP website www.web.net/cielap

An evolution of CIELAP's environmental analysis has been to assess the attention the Ontario public is paying to environmental issues and how environmental issues reflect on citizens perception of governance.

CIELAP arranged with OraclePoll Research Ltd. to include several questions related to contamination of drinking water in Walkerton, and the impacts this has had on citizen perception of government and leadership in a province-wide Omnibus poll.

The poll shows that "Our concerns about the decline of environmental protection in Ontario are mirrored by the people of Ontario" said Ms. Mitchell.

It is noteworthy that virtually all (99.4) of the 500 Ontarians polled between June 9-14 were aware of the contamination of drinking water in Walkerton. This Ontario-wide poll has a confidence level of +/-4.4% 19 times out of 20. Here is the question by question results.

1. Are you aware of the recent events concerning the contamination of municipal drinking water with E-coli bacteria in Walkerton, Ontario?
